

AGREEMENT

BETWEEN Eden Digital Limited of Auckland, New Zealand ("the Company")

Agreement

In consideration for the payment(s) listed in the schedule hereto, the Model hereby irrevocable grants to the Company the right to use and disseminate all visual images and voice recordings of the Model as obtained by the company under this agreement. Specifically:

1. The Model agrees and authorizes the Company to record and reproduce on film, tape, photograph or by any other means his/her name and/or alias, likeness, voice and appearance either alone or with others as may be required by the Company and to record and reproduce on film, tape, photograph or by any other means any photograph of him/her which he/she has provided to the Company for that purpose, or which the Company has asked him/her to approve such use of ("the Material"),
2. The Model authorizes the Company to edit the Material and to incorporate the Material into any film or publication and any related printed materials, advertising and publicity for the Company's use at its sole discretion.
3. The Model authorizes the Company to exhibit, use, sell and exploit the Material or any part thereof incorporating the Material in all media throughout the world at any time and grants to the Company the non-exclusive right to use his/her name and alias, likeness and biography for publicizing and promoting the Material and to use the Material in any related printed media, advertising and publicity.
4. The Model acknowledges that the Company has explained to him/her and that the he/she has understood the nature and style of the Material, their appearance in the Material and the Company's business.
5. The Company may, at its discretion, credit the Model and/or the Model's alias in the use of the Material. The Company shall determine the position and size of any such credit.
6. The Model acknowledges and agrees that the copyright in the Material is vested in the Company and to any extent necessary the Model hereby assigns absolutely to the Company any interest he/she may have in the Material.
7. The Model hereby releases the Company and any and all persons associated with the Company to the full extent permissible by law from all rights, actions, suits, claims or demands which, but for the Model's execution of this Agreement, the Model may have had and the Model acknowledges that he/she shall not make or assert against the Company, or any and all persons associated with it, any claim or demand for economic or other loss of any kind.
8. By signing this Agreement, the Model certifies that he/she is 18 years of age or older.
9. The Model hereby releases the Company from any and all liability related to any health issues, such as pregnancy, STDs, AIDS or other related diseases which may result from his/hers participation in the Material. The Model warrants that, where appropriate, he/she was given the choice to use condoms or other methods of protection during intercourse.
